Jackie Smith called the meeting to order at 6:00 p.m.

### **Monitoring Reports – ET report**

#### Policy II.B. Staff Changes:

Ruth Kirkland moved to accept the Executive Team report as in compliance with policy II B (Staff Changes). The motion passed unanimously.

(Discussion: A 20-hour/week position for Director of Finance has been posted. There are 10 applicants as of today.)

## Policy II.E. Financial Condition:

Jennifer Tong moved to accept the Executive Team report as in compliance with policy II E. The Financial Condition here refers specifically to the October financial reports. The motion passed unanimously.

(Discussion: Pledges have gone up. The capital loan is going down. Loan reduction is in a great place. Investments are up. The drawdown will happen soon to cover our shortfall. We are in good shape.)

#### Policy II.H. Communication and Counsel to the Board:

Clover Earl moved to accept the Executive Team report as in compliance with policy II H (Communication and Counsel to the Board). The motion passed unanimously.

(Discussion: Sanctuary update: Our guest was moved out of the church into the lower duplex. He will be paying \$600 in rent. We may be getting a new sanctuary guest soon. Our investment team with the help of Tim Brennan will start in January to draft a new policy, and will also include the Currier trust gift which was received in December. The ET will be working with our UUA consultant to create a proposal for the use of the Currier funds which will focus on maintaining a commitment to racial justice in the life of the church. The proposal will be reviewed by the Board for approval.

Nila Gouldin moved to accept the proposal for the allocation for the \$700,000 of the Helener Currier Endowment. The motion passed unanimously.

**Business Matters – Board** 

Nila Gouldin moved to agree to hire the firm SDK for our full audit in 2020. The motion passed unanimously.

(Discussion: The Board hires the auditor.)

Approval of November 2019 Meeting Minutes:

Jill van Koolwijk moved to accept the November 2019 Meeting Minutes with a spelling change. The motion passed unanimously.
